CONTRACT NO. 104/2013: REPAIR WORKS TO FLOOD DAMAGE AT THE WEIR IN THE LIEBENBERGSVLEI RIVER NEAR REITZ

Project Number K3092/2013 will comprise of repair works to flood damage at the weir in the Liebenbergsvlei River near Reitz and will include concrete work, construction of Gabion mattresses and walls. The tender include, *inter alia*, the following provisions:

Tenderers shall have a **CIDB** contractor grading of **Grade 4CE or Grade 3CE PE** or higher. Joint Ventures that have a combined contractor grading designation in accordance with the Construction Industry Development Regulations which is equal to or higher than a contractor grading designation determined in accordance with the sum tendered for a **4CE** class of construction work, are eligible to submit tenders.

To enact the Preferential Procurement Policy Framework Act (Act No 5, 2000) the following **90/10** evaluation criteria will be applied in the evaluation of tenders:

- Price and experience will obtain 90 points;
- HDI owned will obtain 5 points;
- Female owned will obtain 2 points;
- Disabled will obtain 1 point; and
- Local Subcontracting (Nketoana Municipal Area) will obtain 2 points.

A CIDB Registration Certificate, an original and latest Tax Clearance Certificate and a certified copy of Company Registration Certificate reflecting active members must be attached.

FAILURE TO COMPLY WITH THE ABOVE REQUIREMENTS WILL NULLIFY THE TENDER SUBMISSION AND NO CORRESPONDENCE WILL BE ENTERED INTO FOR FAILING TO COMPLY.
